Please read these steps and complete each requirement to appeal:

- I understand that I am being asked to appeal because I am not meeting one of the Satisfactory Academic Progress requirements. At minimum, I must maintain at least a 2.0 GPA, pass at least 67% of the credits I attempt, and complete my program within 150% of the posted timeline (90 attempted credits for most degree programs and 45 attempted credits for most certificate programs). I understand that receiving NA grades, withdrawals, and F grades may make me ineligible for future financial aid at BHCC.
- I am attaching a detailed, typed letter that explains the following topics:
 - Reason(s) I was unable to successfully complete my courses or have attempted more credits than my program allows
 - Specific methods I will use or steps I have taken to be successful moving forwardI understand that my letter requires me to reflect on my academic success. I should write at least two full paragraphs to address the topics above.
- I am attaching documentation of any extenuating circumstances that I discussed in my letter; such as medical issues, recall to military duty, or death of an immediate family member or partner. I understand that failure to provide documentation of the reason for my appeal may result in my appeal being denied or delayed.
- I am certifying that I have completed my academic plan for the Fall 2017 and Spring 2018 semesters. I understand that planning courses that do not meet a requirement for my current academic program of study may result in my appeal being denied. I also understand that my appeal will not be reviewed without a completed academic plan for both semesters and handwritten appeals will not be accepted. If I have any IP grades, I am including information on my expected completion date from my instructor. I am aware that if I need assistance with my academic plan, I should visit the LifeMap Office in Room E-235 on the Charlestown campus.
- I understand that my appeal may take up to 5 business days to be reviewed, but that it may take up to three weeks for my entire financial aid file to be reviewed. I also understand that the final approval or denial of my appeal is at the discretion of the BHCC Financial Aid Office and that, if denied, I will not be eligible for financial aid at BHCC for the 2017-2018 academic year. I am aware that communication about my appeal will be sent to my BHCC email account or posted to my BHCC Self-Service account online.
