Dear Future College Graduate,

We are thrilled that you want to participate in Massachusetts' new *MassTransfer* Pathway Commonwealth Commitment! The Commonwealth Commitment seeks to help you achieve college savings while you earn your degree.

By participating in a *MassTransfer* Pathway, you may be eligible¹ to receive Commonwealth Commitment benefits:

- A freeze on tuition and mandatory fee rates from the moment you enter the Commonwealth Commitment until you graduate from a community college and a freeze on mandatory fee rates from the state university or University of Massachusetts (UMass) campus to which you transfer².
- A ten percent (10%) rebate off frozen community college tuition and mandatory fees at the end of every successfully completed semester.
- Upon transfer to a baccalaureate institution, a *MassTransfer* Pathway 100% tuition waiver (or "credit" at UMass campuses), and a 10% rebate off frozen mandatory fees at the end of every successfully completed semester.

² Freeze reflects the tuition and mandatory fees rates in effect the year the student enters the program. For example: If a student enters the Commonwealth Commitment at Bunker Hill Community College in Fall 2016, that student will be charged the same rates while at BHCC. If the student transfers to UMass Boston in Fall 2018, the student will pay the mandatory fees rates at UMass Boston at their Fall 2016 rates for the next two years and get the *MassTransfer* 100% tuition waiver (or "credit" at UMass campuses). This freeze does not include discretionary fees and non-mandatory fees.

Complete a <i>MassTransfer</i> Pathway associate degree within two and a half years of signing the Participation Form³. • When transferring to Massachusetts state university or UMass campus: <ol style="list-style-type: none"> a. Immediately following completion of a <i>MassTransfer</i> associate degree, enroll as a degree-seeking student in a <i>MassTransfer</i> Pathway major (continuous Fall/Spring semesters). <ul style="list-style-type: none"> ▪ <i>Additional forms may be required for admission, students should read correspondence sent from the institution.</i> b. Enroll in <u>at least 15 college-level credits per semester</u> at the same university. c. Maintain a cumulative GPA of 3.0 or above (not including developmental course work). d. Complete a bachelor degree within two years of transferring. • When transferring to Massachusetts College of Art and Design or Massachusetts Maritime Academy: <ol style="list-style-type: none"> a. After 1.5 years of signing the Participation Form at the community college, enroll as a degree-seeking student in a <i>MassTransfer</i> Pathway major (continuous Fall/Spring semesters)³. <ul style="list-style-type: none"> ▪ <i>Students may be required to produce a portfolio as part of the acceptance criteria to Massachusetts College of Art & Design.</i> ▪ <i>Additional forms may be required for admission, students should read correspondence sent from the institution.</i> b. Enroll in <u>at least 15 college-level credits per semester</u> at the same institution. c. Maintain a cumulative GPA of 3.0 or above (not including developmental course work). d.
