### Admissions Information:

Admission to one of the four Medical Imaging Programs is competitive and seats are limited. Attending the mandatory information session early in the application process will help you learn about all the requirements to plan ahead. Please schedule a time to meet with an Admissions Pathway Counselor to clarify the application process, review your completed requirements, missing requirements and remaining documents needed before the application deadline.

## Medical Imaging TEAS (ATI TEAS) Requirements & How to Register for BHCC

<input type="radio"/>	<p>Date of 1st TEAS Test Attempt: <b>Test Location:</b></p> <p>BHCC <b>Other Testing Site:</b> Location:</p>	<p>Take the TEAS VII test within <u>ONE YEAR</u> of the application deadline (30 day between attempts)</p> <ul style="list-style-type: none"> <li>• The TEAS test is offered on campus or remotely at Bunker Hill Community College.</li> <li>• The TEAS test can only be taken a maximum of two times within one year of the deadline. If you take the test more than twice, only the first two attempts will be considered with your application.</li> <li>• Applicants must meet the minimum scores of: <ul style="list-style-type: none"> <li>• 47.6% percent on reading</li> <li>• 46.7% percent in math,</li> <li>• 47.6% percent in English/Language</li> </ul> </li> <li>• BHCC will use the highest score in each section from each test</li> <li>• There is no rounding of TEAS scores.</li> </ul>

You may register to take the test at any testing site location. ### **Program Options**

- Full-Time Cardiac Sonography | 24 months in duration
- Full-Time General Sonography | 24 months in duration
- Full-Time Medical Radiography | 21 months in duration
- Part-Time Medical Radiography | 35 months in duration

### **Admissions Rubric Criteria**

Applicants are reviewed based on the admissions rubric criteria below, to ensure consistent evaluation of all applicants

- **Required:** Pre-Requisite Course Grades (Meets the minimum requirements to apply) \*
- **Required:** Medical Imaging Programs - ATI TEAS Test Scores (Must meet the minimum score requirements to apply) \*Grades on the pre-requisite course and ATI TEAS Test Scores are heavily weighted for admission decisions
- **Not Required:** General Education Courses, additional Lab Science course Grades: Courses that can be taken prior to applying that will make students a more competitive applicant (not required to apply)
- **Not Required:** However, will add slightly to your ranking in the applicant pool: 2 Years of healthcare work experience or less, or 3 or more years of healthcare work experience, and/or completion of an Associates Degree or Bachelor's Degree with supporting documents submitted to Admissions.

### **Waitlist Status**

Each application cycle (Fall Semester) a waitlist may be created for qualified Medical Imaging Program applicants. The number of students that are placed on a waitlist changes each semester. Waitlisted students will follow the same process as accepted students and attend the program specific orientation to maintain their place on the waitlist in preparation to fill a vacancy in the program should it become available. The number of students admitted from the waitlist changes with each application cycle. Acceptance off the waitlist is not guaranteed. Waitlist status is only applicable for acceptance into the current semester the student is applying for. Students not selected from the waitlist, if interested will need to reapply for consideration of acceptance in a future semester.

## **Criminal Offender Record Information (CORI) and Sex Offender Record Information (SORI)**

As a prerequisite for a clinical placement this program requires that all students must undergo a Criminal Offender Record Information (CORI) check and a Sex Offender Registry Information (SORI) check.

## **Required Immunizations:**

**Students who are admitted into the program must provide proof of the following vaccines/immunizations to Health Services**

### **Due: 1 month prior to the start of clinical:**

- Tetanus, diphtheria and pertussis: (TdaP) vaccination required within the past 10 years, then a Td booster every 10 years
- MMR- evidence of two live vaccinations or immune titer results required
- Hepatitis B- Evidence of three doses of Engerix-B or Recombivax-HB formulations of the hepatitis B vaccine on a 0, 1, 6 month schedule or 2 doses of the Heplisav-B formulation on a 0 and 1 month schedule. Test for hepatitis B surface antibody (anti-HBs) 1-2 months after final dose in the series to document immunity.
- Varicella (chickenpox) - evidence of two vaccinations or immune titer results required
- Meningitis- Menveo or Menactra dose required after 16th birthday for all newly enrolled students between 16-21 years old. (These vaccines are known as MenACWY, formerly listed as MCV4.)

### **Due by: October 1st (annually)**

- o Influenza Vaccination: required by October 1st (annually).
- o Physical Exam: The exam must be within 1 year of the program start date.

### **Due Between: June 15th - August 15th**

- Tuberculosis Screening. Student must receive either IGRA- serology (T-SPOT or Quantaferon GOLD) or Mantoux testing (PPD).
- If a student has a positive (PPD) please contact the health coordinator for further instructions.
- COVID vaccination
  - o All health professions students are required to be fully immunized for COVID 19.
  - o A student is considered fully immunized 2 weeks after their 2nd dose of a 2 dose series, such as the Pfizer or Moderna vaccines OR 2 weeks after a single dose vaccine, such as Johnson & Johnson's Janssen vaccine. In addition, most clinical sites require students to have received a Booster dose. As COVID-19 continues to evolve, students are advised that additional COVID-19 immunizations/ boosters may be required by clinical sites as a condition of attendance. Clinical sites have sole discretion with regard to their COVID-19 immunization/booster policy and failure to comply could result in a student forfeiting their clinical placement.
